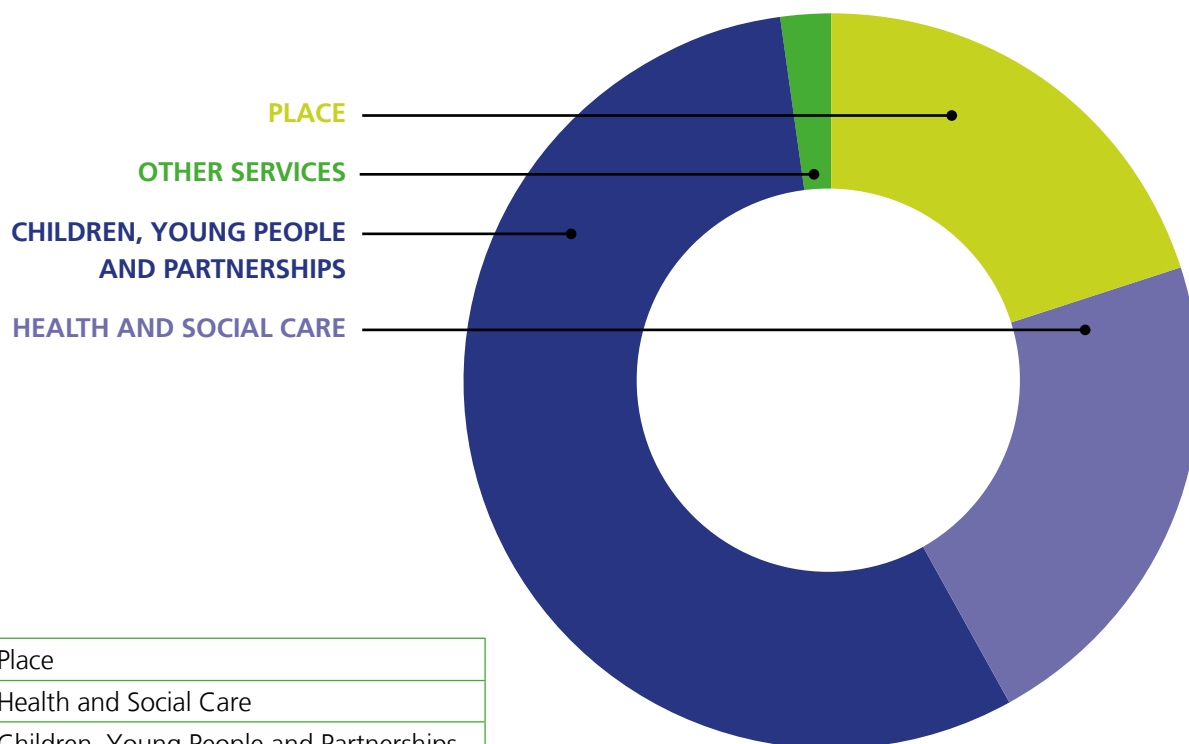

An increase of 4.84% was agreed by Council in setting the 2020/21 budget on Tuesday 11 February 2020. This applies equally across all bands.

Council Tax is applied across a range of bands from A to H, with all bands having a relationship with Band D, known as the multiplier. The Scottish Government legislated to increase the Council Tax multipliers for properties in bands E to H from 1 April 2017.

Single person households with a net income of up to £16,750, and all other households with a net income of up to £25,000 and less than £16,000 in savings, will be protected from the increased charge caused by the Band E to H multiplier change. DIRECT DEBIT

Council Tax

If you want to pay your Council Tax by direct debit, you can pay by 10 or 12 instalments, on either the 1st, 16th or last day of each month. If you choose the 12 month option your instalments will be smaller. You will ensure that your account is always up to date. If you want to change to direct debit it's now easier than ever, simply call **0131 271 3201** and you can set up your direct debit there and then. No need to fill out forms - just have details of your bank account handy and it can all be done over the phone in a matter of minutes.

Business Rates

If you pay your business rates by direct debit, you can pay by 10 or 12 instalments, on the 28th of each month. If you choose the 12 month option your instalments will be smaller. You will ensure that your account is always up to date. If you want to change to direct debit it's now easier than ever, simply call **0131 608 1133** and you can set up your direct debit there and then. No need to fill out forms – just have details of your bank account and business rates account number handy and it can all be done over the phone in a matter of minutes.

Debit card or credit card

You can pay your Council Tax or business rates 24 hours per day, 365 days per year. Payments made by credit card will be subject to an additional charge. Call **0131 660 1845** or log on to www.midlothian.gov.uk/pay

Council Tax Reduction could help you pay your Council Tax bill if you are on a low income. It is worked out taking account of your income and individual circumstances. If you are currently in receipt of Council Tax Reduction or Housing Benefit, we will automatically reassess your benefit and if your benefit changes, we will write and tell you.

What should I do next?

If you were previously not entitled to any benefit due to the amount of income you received you may now qualify. You need to fill in a new form to claim benefit and provide the necessary documents to support the information you put on the form. We know forms can be daunting and put people off claiming benefits they are entitled to, however we can provide advice and assistance if required.
