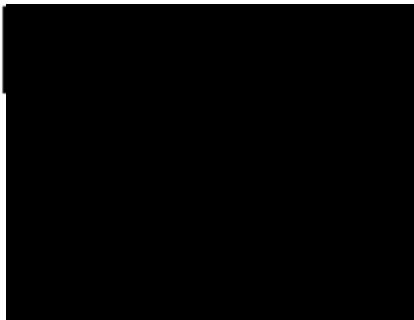

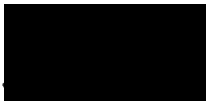

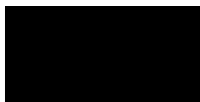
Midlothian Sure Start has worked alongside LASC for over a decade. They are committed to supporting communities through a range of services that enable children to grow, develop and reach their potential.
