#### 1. Title of proposal

Multi agency Risk Assessment Conference (Marac) Operating Protocol 2022 (vs.3): Final Integrated Impact Assessment.

#### 2. What will change as a result of this proposal?

East Lothian and Midlothian Public Protection arrangements include agreement to operate Multi Agency Risk Assessment Conferences (Maracs) in East Lothian and Midlothian which is the highest risk element of our approach to improving the safety of survivors of domestic abuse and their families. Marac is a key part of our delivery of the Scottish Government and COSLA's <u>Equally Safe Strategy</u>.

A Marac is a multi-agency meeting where information is shared about the victims who are at the highest risk of serious harm or murder due to domestic abuse. The meeting provides a safe environment for agencies to share relevant and proportionate information about current risk, after which the Chair will summarise risks and ask agencies to volunteer actions to reduce risk and increase safety.

The aims of Marac are to:

- Work with victims of domestic abuse to help keep them safer and respond to their needs;
- Manage perpetrators' behaviour to reduce risk;
- Ensure that risk and support needs attached to family members or extended networks are identified;
- Maintain the safety and welfare of professionals; and
- Make links with other protection processes (such as Child Protection, Adult Support and Protection, Multi-Agency Task and Coordination groups, Multi-Agency Public Protection Arrangements)

The Marac Operating Protocol has been in place since 2015. This third iteration of the Marac Operating Protocol sets out the operation of our Maracs in accordance with the <u>10 Principles of an Effective Marac</u> and the <u>Toolkit for Marac in Scotland</u> from <u>SafeLives</u>, which is recognised as the lead agency for domestic abuse risk assessment and the Marac model.

The Purpose of the Marac Operating Protocol is to:

• Establish accountability, responsibility and reporting structures for Marac;

- Outline the process for the Marac;
- Enhance existing safeguarding, public protection and information sharing protocols and arrangements, rather than replace them; and
- Support existing policies and procedures regarding multi-agency working on domestic abuse.

The Marac Operating Protocol will ensure the correct functioning of Marac in accordance with the SafeLives model referred to above. Marac is also supported by Marac Quality Assurance processes and measures to guide improvement.

Ultimately Marac will reduce risk and increase safety of victims of domestic abuse at high risk of serious harm or murder.
