On behalf of Rosewell and District Community Council I am writing this letter of support for the expansion of the LASC building and services in Rosewell Park.

RDCC were contacted by Irene Hogg, CEO of LASC Childcare Services, who described the current service needs of the area, and we were already familiar with her current service provision. We have been shown plans of the proposed extension and the initiative was discussed at the public meeting of the RDCC and local residents on Monday 21st November. There was unanimous agreement from both the committee and all residents present at the meeting, that this proposal would be a great benefit to Rosewell, it's residents and the wider population of Midlothian. This building provides several services, is a much-needed resource for the people of Rosewell, and provides much needed employment.

We feel the expansion of the building and service would enhance and improve life in our community. It would support the economic development of our village and surrounding area, and would also promote Rosewell and our community as the LASC services are open to all Midlothian residents.

Whilst we have not yet seen drawings of the proposed aesthetic of the building, we feel that an extension on the proposed side of the building would add environmental enhancement to our village as this side is currently a bland wall and a grass area with the remains of an infected tree. The layout of Rosewell Park is such that this corner of the park is not frequented by residents or used for any other specific outdoor use, so we would be supportive of the LASC being given a much larger footprint than the proposed plan. In view of the health benefits, both physical and mental, of outdoor education and time, RDCC would support LASC being given more outdoor space than the current proposal of only a building extension. Whist we are aware that there are regulations about the square footage of public park, we hope that discretion can be used when the proposed initiative would bring such great benefit to so many people and their families.
