The legislation provides a process for community transfer bodies to follow but it is a very involved, staff intensive and lengthy process.

Following a number of CATs since the Act came into effect, we have embarked on a review of our CAT policy and associated processes. This is taking the learning from CATs to date and the feedback from the services directly involved in the process and feedback from applicants during the process. We anticipate this review to be concluded during Q3 2022/23 with a revised policy presented to CAT Committee for adoption.
