Use of the Event Field

The named booking holder must:

- Obtain all necessary licences required for the operation of the event.
- Provide all necessary facilities (eg: toilets, drinking water, waste collection) appropriate to the event.
- Prevent any activity that may breach any licence granted or invalidate insurance cover.
- Ensure all required safety measures are maintained throughout the event.
- Ensure the supervision and management of all vehicles, spectators, competitors and officials and their access to and from the Event Field
- Ensure the Event Field is vacated promptly at the end of the booking period.
- Ensure the Event Field is left in a good repair and condition.
- Ensure all privately owned equipment is removed immediately after the event.
- Ensure appropriate arrangements are in place for the removal and disposal/recycling of any waste generated by the event.
- Allow authorised Council representatives unrestricted access to inspect the event and the safety and/or security measures in place.
- Not make, or allow others to make, any alterations to the Event Field.

Termination and Cancellation

Midlothian Council reserves the right to:

- Refuse any booking request.
- Terminate any booking where a breach of health and safety or licensing conditions is identified.
- Cancel a booking if Vogie County Park is closed due to adverse weather conditions or industrial action. Any fees paid will be refunded.
