How your personal Information is used by Environmental Health

Under the Data Protection Act 2018, you have a right to know how we collect, use and share your personal data. Environmental Health carries out a wide range of regulatory functions for Midlothian Council. In doing so we collect information about individuals and businesses. We enforce the laws in areas such as private sector housing, food safety, workplace safety and environmental crime. We also issue various licences. This privacy notice explains the information Environmental Health needs in order to carry out these functions.

Environmental Health is part of the Communities and Economy service provided by Midlothian Council. More information about the Communities and Economy Service privacy notice can be found on the Councils website

Our Privacy Promise

We promise to collect, process, store and share your data safely and securely.

What lets us collect your information?

Environmental Health processes your personal information in accordance with the following data processing conditions:

- Where processing is necessary for the exercise of official authority or for the performance of a task carried out in the public interest
- Where processing is required by law

The main laws under which Environmental Health can process your information in relation to caravan site licensing are:

- Caravan Sites and Control of Development Act 1960
- Caravan Sites Act 1968
- Health and Safety at Work etc. Act 1974
- Refuse Disposal (Amenity) Act 1978
- Water (Scotland) Act 1980
- o Water Services etc. (Scotland) Act 2005
- Water Intended for Human Consumption (Private Supplies) (Scotland) Regulations 2017

What kinds of personal data do we collect?

The personal data we collect might include your name, date of birth, address, National Insurance number, or other information that identifies you. If necessary, we might also collect what is called 'special category' data — that is, sensitive information such as your gender and medical/health information.

How do we collect your personal data?

We collect your personal data in many different ways. You might give us your personal data yourself, by entering your information in an application form, a contact form on the Council website or by contacting a Council officer in person, in writing or over the phone. We might also receive your personal data from other council services, other agencies or local authorities.

How do we use your personal data?

The personal data collected from you may be used in different circumstances:

- For the purposes of performing any of our statutory enforcement duties
- to contact you about a complaint, service request or application you have made to us
- to maintain any registers that the law requires us to keep
- If you have applied for a licence of some sort we may use your personal data to check that
 you have not been disqualified from holding a licence, committed certain offences relating
 to fraud, violence or drugs, or contravened any laws, rules or agreements that may stop
 you being issued with a licence
- to determine if you are a fit and proper person to be a caravan site licence holder
- for the collection of any fees due to the Council

Do we share your personal data?

We will only share your personal data if it is necessary to do so and the appropriate conditions have been met to protect it. We will share your personal data if we are compelled to share it by law. If we share information regularly with another organisation, the conditions for sharing your personal data are set out in an Information Sharing Agreement or are permitted by legislation.

With whom do we share your personal data?

Your Personal data may be shared with other Midlothian Council services where we are carrying out a regulatory function or where it is necessary for us to carry out a service you have asked us to. We may share your personal data with other persons authorised by Midlothian Council to act on our behalf in carrying out the requirements of the above legislation such as contractors If necessary, we might share your personal data with other agencies and authorities, depending on the service being provided.

The external bodies with whom we might share information to carry out are functions include (organisations with a star are mandatory):

- Health and Safety Executive
- Scottish Environment Protection Agency
- The Procurator Fiscal Service*
- Police Scotland
- HMRC
- Scottish Government
- Lothian and Borders Fire and Rescue Service
- Other local authorities

How long do we keep your personal data?

Your personal data is kept in line with Midlothian Council's Retention Schedule. The retention schedule sets out the kinds of information the Council creates and uses, how long it should be kept, and what should be done with it at the end of its 'life'. Our retention schedule
